Background: Between 1545 and 1590, Friar Bernardino de Sahagún studied and wrote about Aztec culture with the help of Native peoples. He believed that knowing more about the Aztecs would allow Spain to more easily convert the Aztecs to Christianity. This collection of writings and pictures is known as the Florentine Codex.



“[The disease] brought great desolation: a great many died of it. They could no longer walk about, but lay in their dwellings and sleeping places, no longer able to move or stir. They were unable to change position, to stretch out on their sides or face down, or raise their heads. And when they made a motion, they called out loudly. The pustules that covered people caused great desolation; very many people died of them, and many just starved to death; starvation reigned, and no one took care of others any longer. On some people, the pustules appeared only far apart, and they did not suffer greatly, nor did many of them die of it. But many people’s faces were spoiled by it, their faces were made rough. Some lost an eye or were blinded.”

Facts vs. Opinions vs. Reasoned Judgment.

Fact: A conclusion that can be proven true and/or is absolutely accurate to all people involved.

Opinion: belief or preference about something that cannot be proven or accepted by all people.

Reasoned Judgment: a conclusion that may not be entirely accurate based upon facts and evidence.

For many people, it seems that when the pustules were spread far apart, they did not suffer a greatly as those that had more pustules.
